Points to cover when speaking with potential nominees for Foundation membership on Board or Committees:

- 1. St. Joseph's Foundation of Thunder Bay is a separate corporation from St. Joseph's Care Group – separate board of directors, mission statement, letters patent, bylaws, policies, etc.
- 2. Ask if they currently serve on other foundation boards, i.e., Thunder Bay Regional Health Sciences Foundation/ Northern Cancer Research Foundation, United Way, Lakehead University, Confederation College, etc.
- 3. This is a Foundation of The Sisters of St. Joseph of Sault Ste. Marie who are the Members of the corporation. The Board of Directors of St. Joseph's Foundation of Thunder Bay coordinate and are accountable to the Members for the day-to-day operations and fundraising for the Foundation. All money raised is used for the works of The Sisters of St. Joseph of Sault Ste. Marie in the District of Thunder Bay. Therefore, all money raised is used to support the mission of St. Joseph's Care Group.
- 4. The Foundation is the 'fundraising arm' for St. Joseph's Care Group, i.e. St. Joseph's Heritage, St. Joseph's Hospital, and Hogarth Riverview Manor, and Sister Margaret Smith Centre.
- 5. Board members are asked to include St. Joseph's Foundation as one of the charitable organizations to which they donate on an annual basis, as long as they serve on the Board.
- 6. The Board (and Committees) holds lunch meetings at the Heritage, scheduled from September to June. Members are expected to attend 70 percent of Board meetings as well as serve on a minimum of one committee (Development, Endowment, Planned Giving, Audit, and Nominating).
- 7. The Executive Director is Gail Brescia. A list of the current Board of Directors is available on the Foundation's website at <u>www.sjftb.net</u>

- 9. Members of the Foundation Board are expected to actively participate in fundraising activities, attend events, and may be asked to approach individuals/businesses for donations.
- 10. The expected term of office is three years, with a maximum of three terms (nine years).
